The grade 7 and 8 students will be celebrating the end of the school year by going to the Waterpark at West Edmonton Mall in Edmonton, on **June 28, 2018**. The students will be traveling by bus leaving Clear Vista School at 8:45 am and returning to Clear Vista School at approximately 3:15 pm. The students will need to bring money to purchase lunch, also to rent a locker, water tube or a life jacket if they choose.

STUDENTS WILL NOT BE ALLOWED TO LEAVE THE WATERPARK - OR ALLOWED TO GO TO ANY OTHER AREA OF WEST EDMONTON MALL. NO OUTSIDE FOOD OR DRINKS ARE ALLOWED INSIDE THE WATERPARK.

FORMS ARE DUE NO LATER THAN JUNE 21st. No late forms will be accepted

ELEMENTS OF RISK

Educational activity programs, such as activities mentioned above, involve certain elements of risk. Injuries may occur while participating in these activities. The following list includes, but is not limited to examples of the types of injury, which may result from leaving the school grounds.

1. Traffic accidents that may occur while traveling by bus to West Edmonton Mall and returning to Clear Vista School.
2. Pedestrian accidents that may occur while crossing a street, walking to and from the bus.
3. Personal injuries that may occur while at West Edmonton Mall such as tripping, falling, drowning, allergic reactions, choking on food/drink, bruising, broken bones/sprains etc.

The risk of sustaining these types of injuries result from the nature of the activity and can occur without fault of either the student, or the school board, its employees/agents or the facility where the activity is taking place. By choosing to take part in this activity, you are accepting the risk that you/your child may be injured. The chance of an injury occurring can be reduced by carefully following instruction at all times while engaged in the activity. If you choose to participate in these activities, you must understand that you may bear responsibility for any injury that may occur.

I, the Parent/Legal Guardian, have read the above, I understand that there are risks associated with participating in the program/activity described above. I assume responsibility to do all within our influence to reduce and eliminate those risks.

I, the Parent/Legal Guardian accepts that School Board's Student Accident Insurance does not apply during the transportation portions of the trip, and the student is only covered from when he arrives at the school sponsored off-site activity, until he leaves the off-site activity.
