INFORMED CONSENT/PERMISSION FORM FOR EDUCATION TRIP

Gr 4 Fort Edmonton - May 23, 2018

The Grade 4 classes will be taking a field trip to Fort Edmonton on Wednesday, May 23, 2018. They will be traveling by bus, leaving Clear Vista at approximately 8:45 a.m. and returning at approximately 3:00 p.m. There is a \$19.00 fee for this field trip. The fee can be paid online or with cash/cheque payable to Clear Vista School.

Students will need a **bagged** lunch (*disposable/recyclable containers only please*). This guided and self-guided tour will include lots of walking, so please have your child come prepared. Students may bring money to make a small purchase at the souvenir shops if they wish (optional).

ELEMENTS OF RISK

Educational activity programs, such as a trip to Fort Edmonton Park, involve certain elements of risk. Injuries may occur while participating in these activities. The following list includes, but is not limited to examples of the types of injury which may result from leaving the school grounds.

1. Traffic accidents that may occur while traveling by bus to and from Fort Edmonton Park.
2. Pedestrian injuries that may occur while walking to/from the bus to/from the Fort Edmonton Park.
3. Personal injuries that may occur while participating in the activities at Fort Edmonton Park, such as: heat exhaustion, dehydration, falling on uneven ground/flooring/steps, bruising, spraining of ankle, broken bones, allergic reactions, etc.

The risk of sustaining these types of injuries result from the nature of the activity and can occur without fault of either the student, or the school board, its employees/agents or the facility where the activity is taking place. By choosing to take part in this activity, you are accepting the risk that you/your child may be injured. The chance of an injury occurring can be reduced by carefully following instruction at all times while engaged in the activity.

If you choose to participate in the field trip detailed above, you must understand that you may bear responsibility for any injury that may occur.

I, the Parent/Legal Guardian, have read the above, I understand that there are risks associated with participating in the program/activity described above. I assume responsibility to do all within our influence to reduce and eliminate those risks

I, the Parent/Legal Guardian accepts that School Board's Student Accident Insurance does not apply during the transportation portions of the trip, and the student is only covered from when he arrives at the school sponsored off-site activity, until he leaves the off-site activity.
